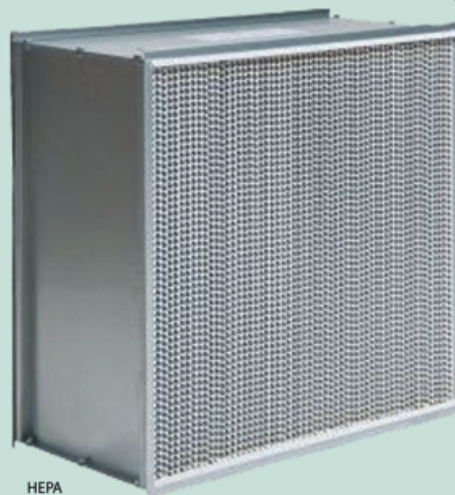

## Laminar Air Flow



LAF systems are used in various applications such as life science research, microbiology, IVF, pathology lab, plant tissue, etc. LAF stations are built w.r.t. the type of process being performed. The cabinets are typically designed to protect the working area (except bio-hazards) and do not offer operator protection. It maintains cleanliness Grade A / Class 100 underneath of HEPA filtration.

## Isolators (upto OEB 5)



Isolators are typically equipped with a fully reproducible and validatable system for bio decontamination (mostly H<sub>2</sub>O<sub>2</sub>) and a process AHU that, as well as permanent overpressure/ Negative control of the process area compared to the operator environment in the clean room. An aseptic isolator protects the product from contaminants in the environment.

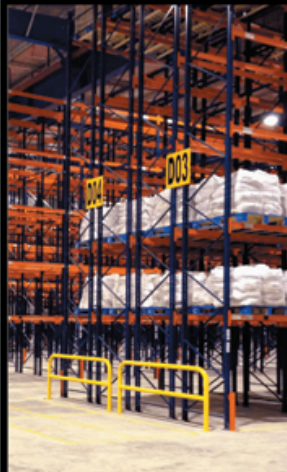

Patented Clean room technology with combi solution of HEPA filter and Light fixtures in common Terminal, Reduces Cleanroom cost with the same footprint.

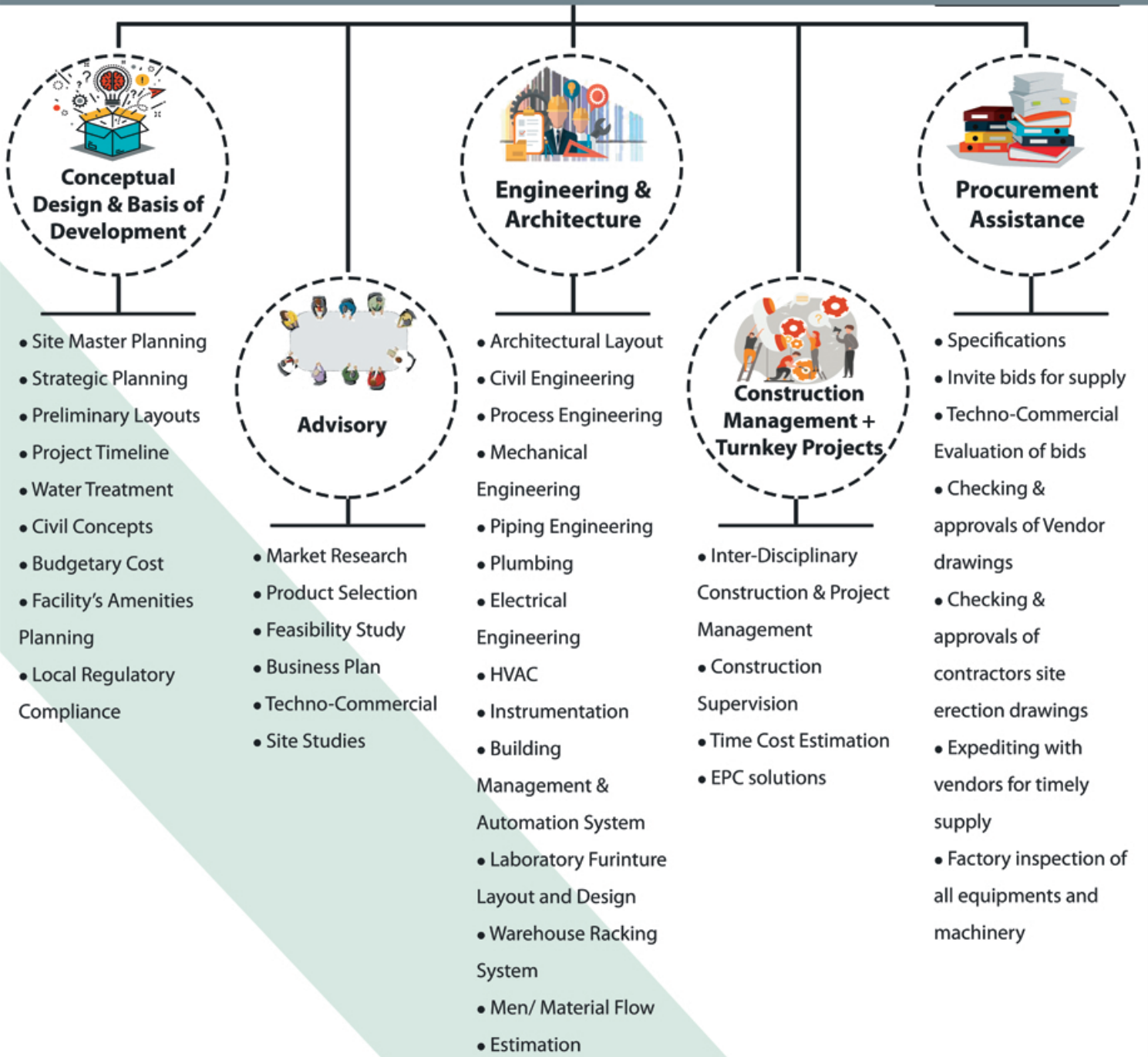
## Passbox

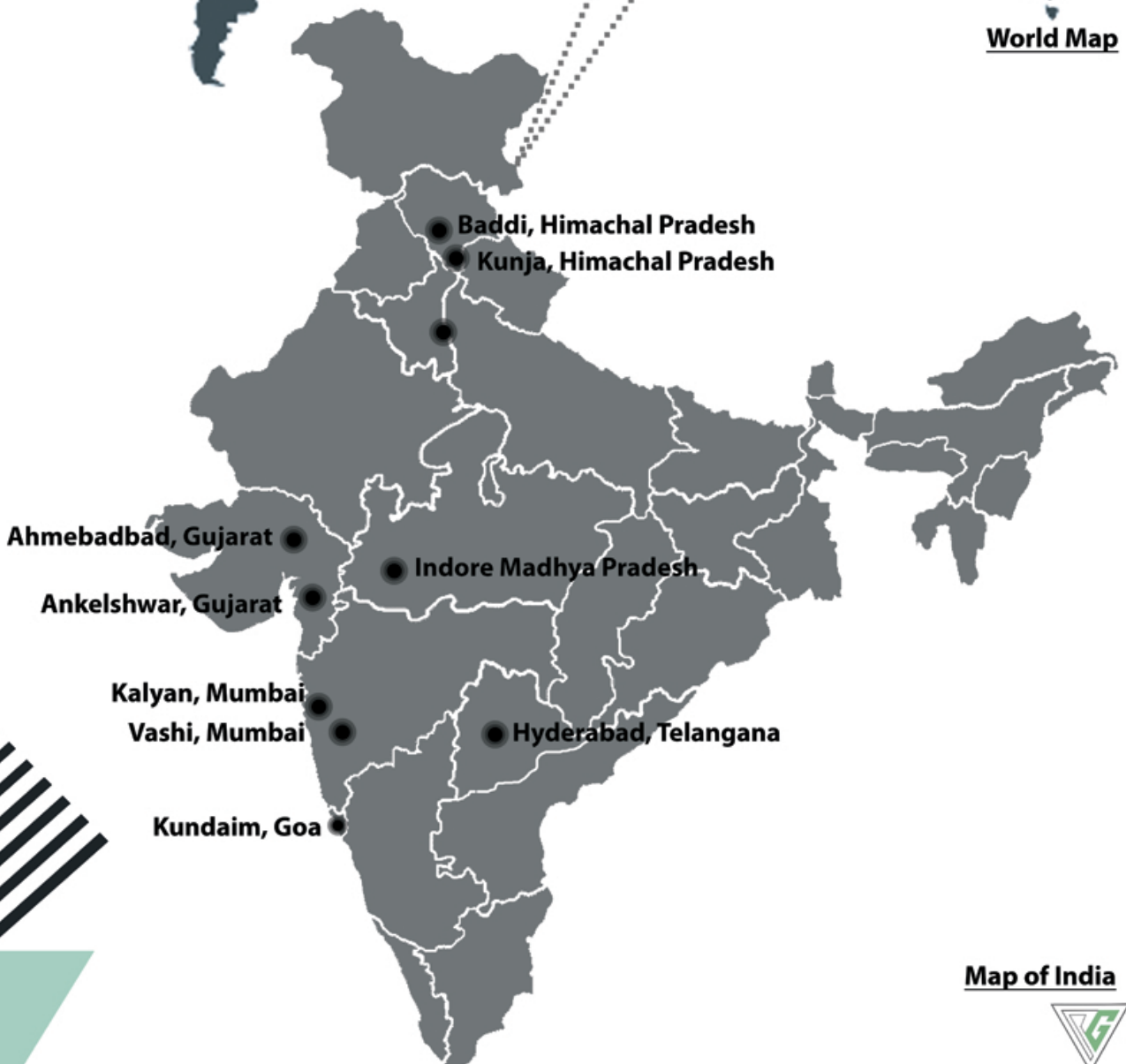
